FACTS	WHAT DOES SECURITY LIFE OF DENVER INSURANCE COMPANY (“SLD”) DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> • Social Security number and account balance • Assets and transaction or loss history • Employment information • Financial information • Health information
How?	All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons SLD chooses to share; and whether you can limit this sharing.

Reasons we can share your personal information	Does SLD share?	Can you limit this sharing?
For our everyday business purposes – such as to process your transactions, maintain your account(s), service your account, maintain required records, respond to court orders and conduct legal investigations, detect and prevent fraud, or report to credit bureaus	Yes	No

Who we are

Who is providing this notice?

This notice is provided by Security Life of Denver Insurance Company and certain of its affiliates. A list of these affiliates is provided at the end of this notice.

What do we do

How does SLD protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with state and federal law. These measures include computer safeguards and secured files and buildings.

How does SLD collect my personal information?

We collect your personal information, for example, when you

- give us your contact information
- make changes to your policies
- visit our website
- manage your account

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes – information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on your account.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- Our affiliates include the SLD Affiliates set forth below.

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- SLD does not share with nonaffiliates so they can market to you.
- We use service providers and third party administrators to perform certain services, which may include check processing, account maintenance functions, withdrawals and claims.

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- SLD does not jointly market.
