



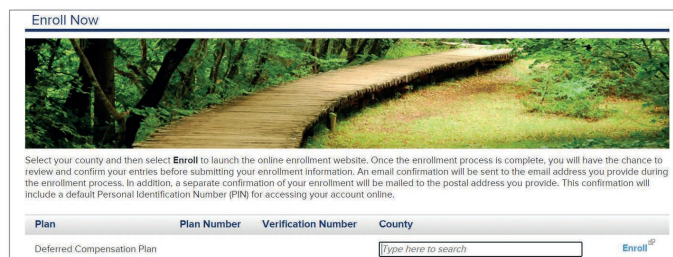
## Enroll in the Florida Deferred Compensation Plan

You can enroll in the Florida Deferred Compensation Plan online – it’s fast, easy, and entirely at your convenience. To begin, go to [florida457.beready2retire.com](http://florida457.beready2retire.com) and follow these steps:



### Enroll now

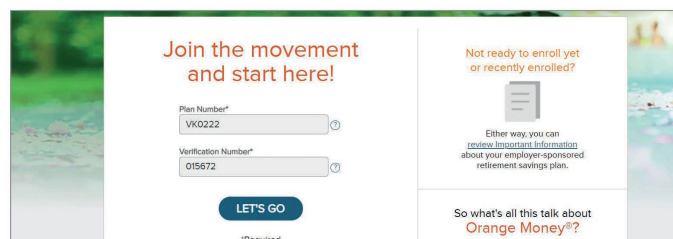


### Login page

The next page will pre-fill you with the following information:

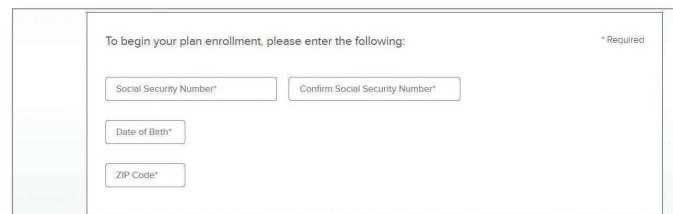

Click *Let's Go* to begin the online enrollment process.



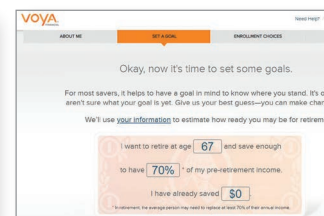
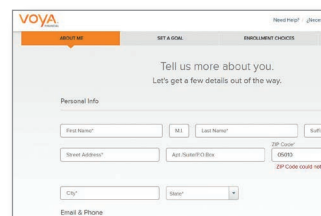
### Begin your plan enrollment

## Make your choices

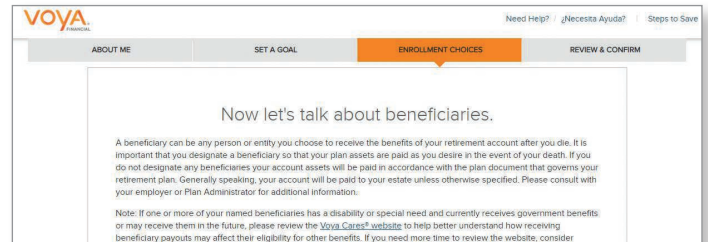
**Contribution Amount** – Enter the amount you wish to contribute to the plan in EACH PAY PERIOD, either as a percentage of your salary or as a fixed dollar amount.

## Beneficiary information

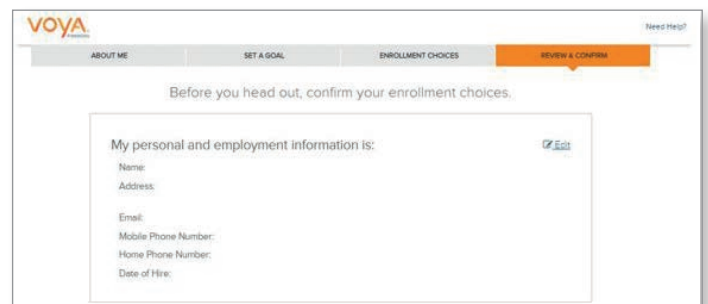
Provide your beneficiary information. You can elect to do it later, but we recommend making an election at enrollment.
